## A. Description of original monument and accessories and/or subsequent restoration:

C-10 1/4 Corner Common to Sections 29 & 30, Town 46 North, Range 1 West

- 1845 Original corner (James Mullett) was an 8" Birch.
- 1891 County Surveyor Frederick H. Brown notes in Section 30 show this as an original corner, with a distance of 2635 feet to the original section corner to the south.
- 1907 County Surveyor Frederick H. Brown notes in Section 29 show this as an original corner, with a distances of 2625 feet to the section corner to the south and 2460 feet to the section corner to the north. An overall distance between said section corners is shown as 5085 feet.

## B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

This corner is being re-established as part of the Chippewa County Remonumentation Program.

Found no evidence of corner. The distance between recovered section corners C-9 to the north and C-11 to the south is 5084,65 feet. compared to 5085 feet as shown in above mentioned Brown notes. The distance from section corner C-9 south to north 1/16 line fences in both Sections 29 and 30 is 1229.7 feet, compared to Brown's distance of 1230 feet. Re-established corner on line between section corners north and south at a pro-rated distance according to County Surveyor notes (2459.83 feet north and 2624.82 feet south). Corner falls in the centerline of a north-south seasonal road, approximately 15 feet north of fence lines east and west. Based on other evidence, I do not believe that these fences were built based on the original corner location.

## C. Description of monument for corner and accessories established to perpetuate locating the position of the corner;

Corner is a ¼" x 24" rebar with a plastic Chippewa County Remonumenta	ion cap in the centerline of a north-south seasonal dirt road,
approximately 15 feet north and the extension of fence lines east and west.	Witnesses:

1/2" Iron with cap #33142, EAST 30.00'

1/2" Iron with cap #33142, WEST 30.00"

Corner Fence Post, S69°W 32.88'

Fence Post, N55°W 33.31'

Note: Unless noted otherwise, distances are to a nail/tag #33142 in the side of the witness object. Bearings are compassed corrected for declination.
