

A. Description of original monument and accessories and/or subsequent restoration:

(I-6) 1/4 Corner Between Sections 14 and 15, T. 47 N., R. 1 W.

- James H. Mullett set post for corner in original survey.
- 1908 Sketches and notes in County Surveyors office show the mile measuring 5300' but make no mention of 1/4 corner.
- 1915 & 1918 Notes and sketches in County Surveyors office show the mile measuring 5282 and evenly divided but make no mention of 1/4 corner.
- 1980 Thomas M. Kelly, P.S. 24599, certificate of survey in section 14 and recorded in L. 2, P. 165, Chippewa County Survey Records, shows 1/4 corner and witnesses.
- William L. Karr, P.S. 27450, found 3/4" pipe and cap set by Kelly. Found no evidence of original corner, 1984 accepted Kelly's position and recorded corner in L. 6, P. 93, Chippewa County Corner Records.
- 1986 Larry R. Rogers, P.S. 29251, in a survey for the City of Sault Ste. Marie Engineering Department in section 14, shows the corner as a 1/2" iron in a monument box.
- 1990 Keith R. Waters, P.S. 33142, certificate of survey in section 15 shows corner as a 1/2" iron in authorities
- B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

(I-6) 1/4 Corner Between Sections 14 and 15, T. 47 N., R. 1 W.

This corner is being perpetuated as part of the Chippewa County Remonumentation Program.

Found a 1/2" iron in a small monument box in a position that matches the one that was set by Kelly and recorded Karr, the pipe was replaced with the iron and monument box during road reconstruction in the mid 1980/sin Could find no contrary evidence to the current location or the corner in available public records. Accepted the corner position as found.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

(I-6) 1/4 Corner Between Sections 14 and 15, T. 47 N., R. 1 W.

The corner is a 1/2" iron in a small monument box in the centerline of 20th Street West.
