

A. Description of original monument and accessories and/or subsequent restoration:

(E-1) Northeast corner of Section 5, Township 47 North, Range 2 East.

Original corner was placed in 1842 by John Mullett. 1920 and 1927 County Surveyor notes refer to original bearing trees and restaurce distance of 2585 feet West to 1/4 corner. Subsequent County Surveyor notes refer to corner as "wire bolt 1" x 36" " with as 3 stone \$12.00 121 feet as a witness..

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner: (E-1) Northeast comer of Section 5, Township 47 North, Range 2 East.

This corner is being perpetuated as part of the Chippewa County Remonumentation Program. Found no evidence of corner or witnesses (including 3' x 3' stone). Re-established corner position on line between North including 3' x 3' stone). 5 and Northeast corner of Section 4, at County Surveyor distance (2585 feet) East of North 1/4 corner of Section 5. Corner falls 20 feet West of extension of centerline of road to North and on extension of centerline of road to West. New corner falls 19.40 feet West of 1/2" iron pin that appears to have been set at the intersection of road centerlines extended from West and North.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner: (E-1) Northeast corner of Section 5, Township 47 North, Range 2 East. Corner is a 3/4" x 24" iron with stamped aluminum cap set flush with ground.
