- B. Description of corner evidence found and/or method applied in restoring or re-establishing corner:
- $\underline{H5}$ $\frac{1}{4}$ Corner common to Sec. 10 & 15 Found $\frac{1}{2}$ " x 18" rebar in Centerline of N-S gravel road per Lapham. This iron appears to represent the road PI set by A.D. Johnson. No evidence of witnesses #1 through #4. Measured Grid bearing and distance of N88°51'00"W 2526.86' (2605.02' – GLO) to 'G5'. Distance East to 'K5' is 7983.7' vs. 7865.22' – GLO. Checked the GLO swamp and topo calls going east from the ½" rebar, as follows: 2509' - Bottom of Bank; 2530' ± to enter open marsh NE-SW (2411' - GLO - Enter open Tam. Swamp C- NE & SW); 2720'± - Searched, dug and probed for wood stake in Marsh but nothing found for GLO 'I-5'; 4021'±10' to leave swamp (3910' – GLO – Leave open Tam. & Cedar C. WNW & SE and center thicket); 4255'±10' to enter swamp (4141' – GLO – Thicket become swamp); 5346' – a fence corner S & E. No GLO evidence for 'J5' found here; 7983.7' to Clare Co. Mon. at 'K5'. It is apparent that a proportional E-W position would be 88' to the east of the ½" rebar. This proportional position would also conform to the GLO topo calls better. Searched this location but all pine stumps in this area are long gone. There was much discussion in the Clare Co. Remonumentation Peer group in regard to the ½" rebar's position and the consequences of moving it East to a proportional position. Facts as presented: 1) the ½" rebar has been used to proportion in existing monuments at 'I-5', 'I-6' and 'J5'; 2) Surveys of record, occupation and title in Sec. 15 are tied to these existing corner positions; 3) The step ladder road built per Johnson's 1932 road survey has been occupied as constructed. Paul Lapham – County Surveyor – says he believed the intent of Johnson's road survey was to follow ¼ and Section Lines and the peer group was inclined to defer to Paul on this point. I believe this is a debatable point. 4) Moving 'H5' - 88' east would create small strips of land on either side of the existing N-S road that would basically be unusable as well as clouding existing title and occupation. Thus it is in the public's best interest to accept the existing $\frac{1}{2}$ " x 18" rebar as the best available evidence of the position of the accepted corner.
