

B. Description of corner evidence found and/or method applied in restoring or re-establishing corner:

Found Fouty's 1/2" bar in monument box as referenced in No. 2 and 3 above. Found this 1/2" bar to be on the Standard Township Line. This location is 1.57 feet North of the split of the distance between corners A-5 and A-7, T5N-R2W. I accepted this monument as the careful and faithful establishment of the original corner position based on the best available evidence. Found no conflicting evidence

C. Description of monument for corner and accessories to perpetuate locating the position of the corner:

Set a standard Clinton County Remonumentation monument, being a 2 1/2" diameter steel tube, 30" long with a standard brass cap, stamped "P.S. 24622", and a breakaway magnetic base at the corner location described in Section 8 above. The monument is witnessed by the following accessories:
