    Monument:Notes by Hollister show he measured the West line of Section 30, T5N-R2W, at 79.84 chains and established the West 1/4 corner at the midpoint (39.92 chains or 2634.72 feet). He used the East 1/4 corner of Section 25, T5N-R3E, to fix the East and West location.

B. Description of corner evidence found and/or method applied in restoring or re-establishing corner:

Found rerod in monument box as referenced in No. 2, No. 8 and No. 9 above. This corner was established using improper procedures and is disregarded here, but should be regarded as a property controlling corner. I re-established this corner on the Standard Township Line. (Between corners M-10 and M-11, T5N-R3W) at midway between corner A-9 and A-11, T5N-R2W. Distances to corners A-9 and A-11 are 2633.60 feet. This is 1.12 feet short of Hollister's distances (39.92 chains = 2634.72 feet). I accepted this location as the careful and faithful re-establishment of the original corner position.

C. Description of monument for corner and accessories to perpetuate locating the position of the corner:

Set a standard Clinton County Remonumentation monument, being a 2 ½" diameter steel tube, 30" long with a standard brass cap, stamped "P.S. 24622", and a breakaway magnetic base at the corner location described in Section B above. The monument is witnessed by the following accessories:
