Found 1/2" Rebar
1/2" Bar & Cap (M-1 Eagle Twp.), South, 116.15'
This location is 0.23' south of the location I calculated as the proportionate measure between A-1 and A-3 and therefore I accept this corner as a careful and faithful reestablishment of the position of the corner.

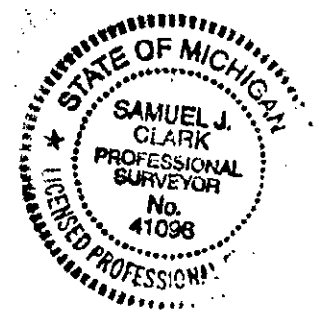
