G-13 [SW COR S.34] FOUND IN PLACE THE ABOVE MENTIONED MONUMENT AS PLACED BY FRANK BRAY IN 1969, ID CORNER MONUMENT BY REFERENCE TO BOTH GUARD RAIL BT'S AS NOTED IN BRAY'S LCR RECORDED IN LIBER 4 ON PAGE 81. ACCEPTED EXISTING MONUMENT AS BEING THE BEST AVAILABLE EVIDENCE AS TO THE POSITION OF THE ORIGINAL CORNER.

H-1 [N1/4 COR S.3] NO ORIGINAL CORNER EVIDENCE FOUND & NO IDENTIFIABLE INDICATION OF SUBSEQUENT CORNER RESTORATION FOUND. REESTABLISHED CORNER POSITION AT MIDPOINT BETWEEN SECTION CORNERS 1/2 MILE EAST & WEST.
