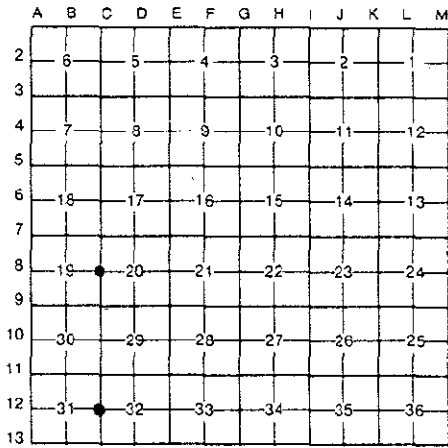

expressed below:

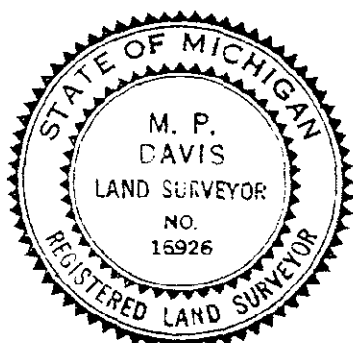

A. Description of original monument and accessories and/or subsequent restoration:  
C-8 [W1/4 COR SEC 20] WOOD POST - A. MERRYWEATHER, D.S. - 1846 (BURNT CEDAR 07°-N18°E-11 LINKS) (BURNT CEDAR 06°-S05°W-13 LINKS)  
M.S. McNABB - 1914 - "NO ORIGINALS FOUND" ID CORNER POSITION BY WOOD STAKE AND IMPROVEMENTS, FENCE POSTS WESTERLY 34.9' & EASTERLY 40.6'  
M.S. McNABB - 1921 - IRON BOLT IN PLACE, BT'S NOTED PREVIOUSLY IN PLACE

C-12 [W1/4 COR SEC 32] WOOD POST - A. MERRYWEATHER, D.S. - 1846 (CEDAR 10°-NORTH-16 LINKS) (TAMARACK 18°-SOUTH-04 LINKS)  
M.S. McNABB - 1915 - ID CORNER POSITION BY WOOD STAKE & BT STAKES NE & SW 33' "CLAIMED TO HAVE BEEN SET BY CRAIG"  
RESET IRON STAKE & BT STAKES N42°30'W-33' & S42°30'E-33'  
M.S. McNABB - 1920 - IRON IN HWY - BT STAKES SET PREVIOUSLY IN PLACE

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:  
C-8 [W1/4 COR SEC 20] FOUND, IN PLACE & 24" BELOW COUNTY ROAD SURFACE, AN IRON BOLT IN LINE WITH FARM FENCE LINES EAST & WEST. DISTANCES TO ADJOINING CORNERS & OCCUPATION LINES CHECK WELL WITH THE RECORDS OF McNABB. ACCEPTED EXISTING MONUMENT AS BEING THE BEST AVAILABLE EVIDENCE AS TO THE LOCATION OF THE POSITION OF THE ORIGINAL CORNER.

C-12 [W1/4 COR SEC 32] NO EVIDENCE OF McNABB'S IRON STAKE FOUND. CORNER POSITION IS LOCATED IN A LARGE FILL SECTION & HAS APPARENTLY BEEN DESTROYED DURING RECONSTRUCTION OF THE COUNTY ROAD. RESTORED CORNER POSITION BY ANGULAR & LINEAL RETRACEMENT SOUTH FROM THE NW CORNER & NORTH LINE OF SEC 32 AS PER THE RECORDS OF McNABB'S 1920 SUBDIVISION OF SEC 32. ACCEPTED THIS LOCATION AS BEING THE BEST AVAILABLE EVIDENCE AS TO THE POSITION OF THE ORIGINAL CORNER.

C-12 SET A 5/8" X 18" REBAR W/A 3-1/4" ALUM CAP STAMPED TO ID COR POSITION & RAISED TO RD SURFACE W/A MON BOX  
ELM 6" N40°W 81.00' SURVEY MONUMENT SIGN POST EAST 25.47' (TO FACE) NOTE: IN FARM LANDS NO OTHER WIT'S AVAILABLE  
ELM 6" N35°E 89.04'
