 - G-2 Set on line and mea. prop. to G.L.O. record between the S.E. and N.E. Section corners of Section 4.
 - E-3 Set at the corner of a very old fence believed to have been built to fit a survey by Marcus McNabb in 1913. McNabb says there were original B.T.s at that time. No sign of them now. Measure south 1/2 mile to McNabbs W. 1/4 corner of Section 9 is almost exactly the same as that recorded in his survey.
