  - D-7 IN1/4 COR S.20] E.C.MARTIN, D.S. 1852 ELM 10" CORNER TREE (CEDAR 18"-N22" W-29 LINKS) NO RECORD EVIDENCE OF CORNER RECOVERY OR SUBSEQUENT MONUMENTATION.
- B. Description of corner evidence found and/or method applied in restoring or reestablishing corner: D-5 [N1/4 COR S.17] NO EVIDENCE OF McNABB'S 1913 CORNER OR HEMLOCK BT FOUND, RESTORED CORNER POSITION ON LINE WITH SEC COR'S 1/2 MILE E & W AND PROPORTIONATE DISTANCE EAST OF AN ANCIENT FENCE LINE TO THE NORTH AT THE W1/16 LINE COR. THE DISTANCE FOR THE WEST HALF MILE OF THE SEC FITS REASONABLY WELL WITH MCNABB'S RECORDS. THE EAST HALF MILE APPEARS TO BE WHERE A BLUNDER OCCURED IN MCNABB'S DISTANCES AS OUR DISTANCE FOR THE LENGTH OF THE TROMBLY RD IS 60' M/L LONGER THAN CONTAINED IN MCNABB'S RECORDS.
