G-7 DNR NBT's: Set one-inch iron pipe/brass cap at found post. Position agrees with distances south & west. Cedar 9 N88W 59 lks(fd.): Tamarack 8 S50W 46 lks(fd. stump).

H-5 DNR NBT's: Set one-inch iron pipe/brass cap near found drill rod/spruce stump. Cedar 8 S70E 12 1/2 lks(fd.): Cedar 8 S30W 8 lks.(fd.)

H-7 DNR NBT's: Set one-inch iron pipe/brass cap midway on line between Section Corners East & West. Aspen 6 N48E 33 lks(down): Aspen 8 N80W 12 lks(down).

I-5 DNR NBT's: Set one-inch iron pipe/brass cap at found post & drill rod. Cedar 12 S74W 35 lks(fd.): Cedar 7 S68E 46 1/2 lks (Fd.)

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner: Magnetic Bearings.

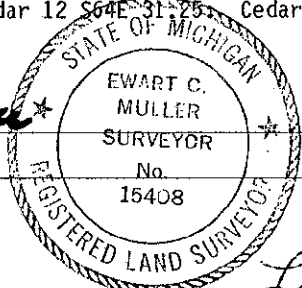
G-7 Found DNR iron pipe/brass cap & post, West of road. [Measurements to 16d nail in notch/side of tree]. NBT's: Cedar 16 North 62.05: Cedar 13 N88W 39.40: Cedar 6 S60W 44.33: Spruce 7 S 02 E 34.75.

H-5 Found DNR iron pipe/brass cap & post west of swamp trail. NBT's: Cedar 12 S34W 5.37: Cedar 11 S65E 8.75: Cedar 12 N82E 8.85: Drill Rod N 04 E 20.55.

H-7 Found DNR iron pipe/brass cap & post North of road. NBT's: Aspen 8 S16E 34.90: R.Mpl 6 North 31.35: R.Mpl 5 S80E 30.05: R.Mpl 7 N88W 33.40.

I-5 Found DNR iron pipe/brass cap & post West of woods road. NBT's: Cedar 17 S80W 24.35: Cedar 12 S64E 31.25: Cedar 9 N40W 29.55: Cedar 11 S18E 37.55.
