FOUND NO MAGNETIC EVIDENCE OF CORNER MONUMENTATION. EXCAVATION WITH BACKHOE REVEALED NO EVIDENCE OF PREVIOUS MONUMENTATION. TRAVERSED ALL OF SECTION 6, TYING IN OCCUPATION THROUGHOUT. 1/4 LINE OCCUPATION (FIELD BREAK/INTERMITTENT TREE LINE NEAR ROAD AND DECAYING FENCE LINE FURTHER WEST) TO THE WEST FROM C-2 IS 12' NORTH OF OLD OCCUPATION FENCE LINE TO THE EAST. DISTANCE FROM 1/8 LINE OCCUPATION (SOUTH) TO FENCE LINE EAST AT C-2 IS 1320.73' AND DISTANCE FROM 1/8 LINE OCCUPATION TO C-6 IS 1320.72'.

SET 20d NAIL W/PLASTIC TAG IN THE NORTHWEST ROOT OF AN 8" MAPLE S38°W 52.60'

SET 20d NAIL W/PLASTIC TAG IN THE NORTH SIDE OF AN 8" MAPLE S66°W 35.92"

SET 20d NAIL W/PLASTIC TAG IN THE WEST SIDE OF A 13" ASH S27°W 43.64"

ON CENTERLINE OF NORTH-SOUTH GRAVEL ROAD (HILL ROAD)

IN LINE WITH FENCE LINE EAST
