Description of corner evidence found and/or method applied in restoring or reestablishing corner:

Found 1 1/4" capped pipe \pm 25' South of East end South guardrail to bridge over Grand River. Cap is unreadable. Found witnesses: Spike with ribbon on top of easternmost guardrail post, South guardrail, North 18.75 feet; Spike with ribbon West side 12" Ash S 45° W 11.16 feet; Spike with ribbon, North side 8" Ash S 30° E 8.39 feet; P.K. Nail and Tag #12034, North side Twin 24" Maple East 19.49 feet; Nail and Tag #30090 (Dave Lohr) East side 36" Maple S 30° W 32.06 feet. 1 1/4" pipe was bent. Excavated until it could be seen where pipe was plumb. Landscape showed evidence of prior extensive cut and fill activities for bridge construction. Therefore no further excavation was performed. Remove 1 1/4" pipe and replaced with 3/4" iron pin with cap stamped PA 345, PS 28414. This surveyor believes that the position of the found 1 1/4" pipe is the proper position for a lost corner as set by Ronnie Lester and found 1 1/4" pipe is the perpetuated position of the set 1/2" bar.
