- A. Description of original monument and accessories and/or subsequent restoration:
- Original corner was set by Hervey Parke D.S. in 1826; bearing tree 6" Beech N 33° E 17 ½ lks and Beech S 41° W 13 lks.
- Marginal note in 1927 on Page 50 of the ECRC copy of GLO notes, Survey
 H. A. Williams calls for this corner to be marked by a stone with a gas pipe on top witnessed by an anchor post N 56° 10' E 29.3 ft. and an anchor post S25° 40' W 72.75 feet.

Found 1/2" rebar at intersection of Toles Hwy. and Arch Road. 1/2" rebar is 0.75' below top of gravel surface. Excavated 12" diameter hole and found 1/2" iron rebar inside of 3/4" iron pipe, 3/4" iron pipe is 1.5' ± below surface. A of Steadman's witnesses are gone. Got magnetic pull at location of 1/2" rod, L1, Page 391. Placed cap stamped "PA 345 PS 28414" on found 1/2" rebar. The location of Steadmans 1/2" rebar appears to be the position of the 1927 Williams corner and appears to represent the historical and perpetuated location for this corner.
