- A. Description of original monument and accessories and/or subsequent restoration:
- 1. Original corner was set by Hervey Parke D.S. in 1826. Set 1/4 Sec. Post, TAM 7 S 40° W 4 lks, DO 6 N 09° W 42 lks V.1, P.44.
- County Surveyor J. H. Gibbons in Vol. 1, Page 57 notes stone 16" S Oak N 70 1/4° W 82 lks, June 1869.
- 3. LCRC recorded in Liber 1, Page 381 by Richard Steadman PS #11370 in February 5, 1974. Dug large hole, but found nothing; falls in muck area. Re-established corner opposite fence line West and on line between adjacent section corners. Set 3/4" iron pipe and cap for the corner in Waverly Road; Nail and Tag in 6" Elm, East-North-East 67.77; Nail and Tag in 6" Elm, Southeast 100.77; West 1/4 Corner, Section 19, T2N, R2W (Set 3/4" iron pipe and cap) is 65.92 feet South.
- Description of corner evidence found and/or method applied in restoring or reestablishing corner:

Found 3/4" bolt with square head in monument box 2.8 feet West of centerline of Waverly Road and on field occupation line to West. Bolt is set in lower level of asphalt ±0.8' below existing road. Bolt is in good condition and left in place. Found 6" Elm as noted by Steadman East-North-East 67.77 feet. Found A-8 Aurelius 65.82 feet South. Assumed bolt in in same position as Steadman's pipe and was placed with monument box during reconstruction of Waverly Road. Accepted position based on method placed by Steadman. Measured 2,654.82 feet North to M-7 and 2,660.32 feet South to M-9.
