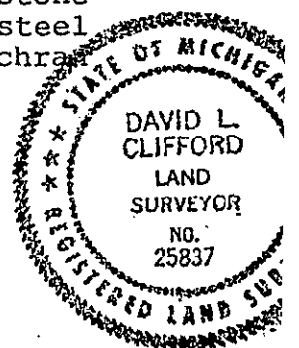

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

Searched at apparent location of corner and found 3/4" pipe in monument box by using witnesses in items A4, A5, and A6. Excavated bottom of box and found stone on S.E. side of pipe. Accepted stone and pipe as perpetuation of corner and set 3/4" X 24" smooth steel bar in top of pipe. Corner lies on extended centerlines of Cochran Road and 5 Point Highway.

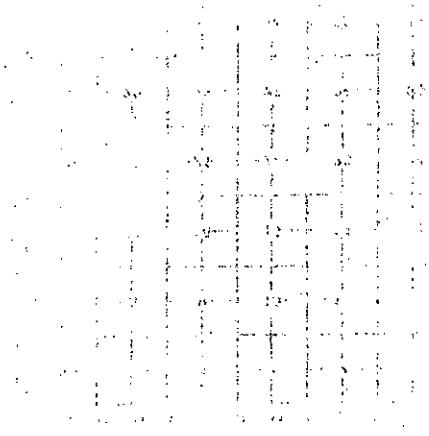
