B. Description of comer evidence found and/or method applied in restoring or reestablishing corner:

Found 1/2" inside diameter pipe 0.5'± below gravel road surface in centerline of Royston Road North & South and 10'± South of Centerline of Gresham Road to the West, and 26'± South of fence line to the East. Excavated 1.5' x 4' deep hole centered on pipe location and found no other evidence. All original and 1938 witnesses are gone. The fence posts used to witnesses the corner in 1954 are also gone, however the third witness to "Tel. Pole" is in and matches. The street sign used in 1982 is also gone, but all other witnesses are intact. Accepted location of 1/2" pipe as the perpetuation of original corner and set in the center of the pipe a 3/4" x 24" form pin with 2-1/2" aluminum cap stamped P.A. 345 Eaton Co. Remon. & PS 41103.

Description of monument for corner and accessories established to perpetuate locating the position of the corner:
