- B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:
 - J-9, Investigation at this corner location revealed a 1" pipe in a monument box 2.4' South of centerline of Vermontville Highway. The Stephens survey (Liber 2, Page 102) and highway plans for M-99 from the Michigan State Highway Department record a distance of 2631.46' between J-9 and K-9. A hole in the ground was found where the fence post noted in Item #4 above likely stood that checked with the found 1" pipe. All the witnesses listed in Items #8 & #11 above were also found and checked the witnesses listed in Items #8 & #11 above were also found and checked closely with the location of the 1" pipe. Dug in the bottom of the monument box to a depth of 3 1/2 feet and a large rock and pieces of crockery underneath 1" square bar and 1" pipe. Accepted 1" pipe as the perpetuated location of J-9 and reset with 3/4" bar 2.0 feet long with cap stamped P.A. 345 and #25832 in monument box.
