Larry A. Bryan, in a field survey on <u>September 28</u>, 19 94 do hereby certify that under requirements of P.A. 74, Michigan P.A. of 1970, the corner points mentioned in lines 1 and 2 above were in conformance with regulations and rules therefore as required in the current manual of survey instructions of the United States Department of the Interior, Bureau of Land Management or by a decree of a Court of Law and/or that the corner points mentioned in lines 3, 4 and 5 above were in conformance with the rules of the Michigan Board of Land Surveyors or by a Decree of a Court of Law, established, re-established, monumented, re-monumented, recovered, found as expressed below:

- B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:
 - K-9, Investigation at this corner revealed a 1/4" boat spike in monument box in the centerline of Hartel Road and Vermontville Highway. Found box in the centerline of Hartel Road and Vermontville Highway. Found nail & tag in power pole, Southeast, 33.28 feet from item #6 and #13, Southwest, 31.39 feet from item #6, and Northwest, 84.10 feet from item #13. All the witnesses from item #7 were found with the distances noted in part "C". 1" pinched pipes were found Northeast, 47.43 feet, and Northwest, 47.26 feet, along with a 3/4" bar Southwest, 46.58 feet, from the plat of the Village of Potterville. Removed boat spike, excavated in monument box to a depth of 1 foot and found 1" pinched pipe below boat spike. Continued excavation to a depth of 3.5 feet but found no additional monumentation. Accepted location of1" pinched pipe in monument box as the perpetuated location of K-9 Benton Township and replaced with 3/4" x 24" bar with cap stamped P.A. 345 #25832.
