Searched area of apparent corner and found 3/4" pipe in monument box. Pulled pipe and excavated to a depth of 3' and found only road gravel as corner is in a fill section for I-96 overpass. Proved pipe as corner using Harvey Williams brick House witness of 1926 which agrees closely with Don Fluke's 1965 witness to the same point and agrees closely with the same witness as measured today. All of Fluke's witnesses are still standing as are Clyde Stephens, Phil Wetosky's and Jim Stephens. Accepted pipe as corner and replaced with standard bar and cap.
