- A. Description of original monument and accessories and/or subsequent restoration:
 - Original post set by Musgrove Evans Deputy Surveyor in February 1827. W. Ash 20" 556°W 19 Beech 7" N27°E 15
 - Oscar Church County Surveyor used Corner in a Survey dated November 1879 and 2. recorded in Volume 1, page 206 as a stone and crockery. (continued on back)
- B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

Searched area of apparent location of Corner and found 1/2" or 5/8" bar in monument box. Was unable to excavate bottom of box because some unidentifiable large piece of iron is also jammed into box. Probed bottom of box and felt what seems to be a pointed stone under bar. Accepted bar as Corner because all witnesses except GLO call for N.W. Corner of Church Wall until the time it was torn down in 1983. Believe that bar is the perpetuation of the original Corner because of agreement with witnesses in items A2, A3, A4, A5, A6, A7, A9 and A12 and because of suspected presence of stone. Set standard bar and cap along side 1/2" or 5/8" bar.

Description of monument for corner and accessories established to polymer and PA345 Cap #11370 in. C. Description of monument for corner and accessories established to perpetuate locating the position of the corner.
