FOUND IRON (AND WITNESSES) BY BRYAN AT FENCE CORNER AS RECITED IN ITEMS #3 & #4 ABOVE. ALSO FOUND ANOTHER FENCE EXTENDING EAST FROM APPARENT NORTH-SOUTH 1/4 LINE, 30.5'± NORTH OF BRYAN IRON. EXCAVATED EXTENSIVELY AROUND FENCE CORNER AND WEST END OF FENCE RUNNING EAST, AND BETWEEN THOSE TWO POINTS. EXCAVATION REVEALED NOTHING. IT APPEARS THAT THE AREA BETWEEN EAST-WEST FENCES HAS BEEN BULLDOZED, AND IT IS PROBABLE THAT THE STONE WITH "X" RECITED IN COUNTY SURVEYOR RECORDS (ITEM #2 ABOVE) WAS REMOVED AT THAT TIME. IT IS MY OPINION THAT THE FENCE CORNER MONUMENTED BY BRYAN IS NOT CONCLUSIVE EVIDENCE OF PREVIOUS MONUMENTATION.
