B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

FOUND IRON BY BRYAN (ITEM #3 ABOVE) AND ALL WITNESSES. AT G-13 WE FOUND THE RECORDED IRON BY LARRY BRYAN. EXCAVATION AT G-13 REVEALED A 2" X 8" PIPE WITH A POINTED IRON STAKE INSIDE, LEANING WEST APPROXIMATELY 3' BELOW ROAD GRADE. 1'1 UNDER PIPE WAS AN 8" X 8" ROUND STONE SURROUNDED BY SMALLER STONES. IRON BY BRYAN WAS 0.8'± EAST OF FOUND PIPE/STONE. ACCEPTED FOUND STONE AT G-13 AS PERPETUATION OF CORNER BY COUNTY SURVEYOR OSCAR CHURCH. EXCAVATION AT F-13, AROUND AND UNDER BRYAN'S IRON, REVEALED NO FURTHER EVIDENCE OF CORNER MONUMENTATION. BRYAN'S IRON AT F-13 LIES 0.27' SOUTH AND 0.37' WEST OF THE TRUE MID POINT E-13 TO F-13.

AS IT WAS BRYAN'S INTENT TO PLACE THE CORNER AT THE MID POINT AND ON LINE, ACCEPTED FOUND BRYAN IRON AS BEST AVAILABLE EVIDENCE OF CORNER POSITION.

REPLACED FOUND IRON WITH STANDARD EATON COUNTY REMONUMENTATION MONUMENT AND INSTALLED MONUMENT BOX.
