

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

FOUND IRON AND ONE WITNESS BY BRYAN (ELM SOUTHWEST). TRAVERSE OF THE EAST LINE OF SECTION 33 CONFIRMS IRON BY BRYAN TO BE AT THE MID-POINT AND ON LINE BETWEEN REMONUMENTED G-11 & FOUND IRON USED BY BRYAN AT G-13. EXCAVATED WITH BACKHOE, CENTERED ON POSITION BY BRYAN, 12'+/- NORTH-SOUTH AND 5'+/- EAST-WEST. AT A DEPTH OF 2'+/- FOUND OLD LOGS TO CORDURDY ROAD. AT A DEPTH OF 2.5'+/- FOUND A LARGE FLAT SIDED STONE (ROUGHLY 22"X 18"X 10") LYING FLAT. ALSO FOUND A NUMBER OF 6"- 8" STONES MOSTLY UNDER LARGE STONE SCATTERED BETWEEN 2.5' AND 4.5' DEEP. AT A DEPTH OF 4.5'+/- ON THE VERY TOP OF THE PEAT LAYER, FOUND THE BROKEN BASE TO AN OLD CROCK. FOUND CROCKERY WAS DIRECTLY UNDER LARGE STONE.

ACCEPTED FOUND CROCKERY AND STONES AS CORNER POSITION PERPETUATED BY COUNTY SURVEYORS FRANK DAVIS AND OSCAR CHURCH.
