B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

D3.....FOUND 1/2" REROD 27463 AS DESCRIBED IN LAND CORNER RECORDATION CERTIFICATE RECORDED IN LIBER 2, PAGE 140.

AFTER REVIEWING EVIDENCE AVAILABLE TODAY, THE EMMET COUNTY REMONUMENTATION COMMITTEE MADE A DECISION TO ESTABLISH A NEW LOCATION FOR THIS CORNER. THE NEW CORNER LOCATION IS AT THE INTERSECTION OF A FENCE RUNNING WORTH AND A FENCE RUNNING EAST. THIS LOCATION WAS FAVORED BY THE COMMITTEE OVER THE LOCATION OF THE 1/2" REROD WHICH WAS BASED ON PROBATION. THE NEW CORNER LOCATION IS 200'+/- NORTH AND 150'+/- EAST OF THE 1/2" REROD. SEE SKETCH ON BACK SIDE OF THIS PAGE.

FOUND 1/2" REPOD WAS REMOVED AND THE NEW CORNER LOCATION WAS MONUMENTED AS NOTED BELOW.


