Description of corner evidence found and/or method applied in restoring or reestablishing corner: В.

1999 REMON - Found 3/4" square bar in centerline of Markley Road and tree run to the east. (In Rowe's field research of this corner we excavated 3-4 feet deep in search of previous monuments.)

In the 1823 GLO survey by H. Parke, a wood post is indicated as the corner, with measurements C-2 to C-1 = 42.34 ct (2794.44) and C-3 to C-2 of 40 ch. (2640 feet). Two accessories are noted, neither of which exist in 1999. In 1937, GCRC drawing with measurements C-2 to C-1 = 2799.24 feet, 4.80 long of 1823 GLO record, C-2 to C-3 = 2666.24, 26.2 feet long of the 1823 GLO survey. No description of the monument is given. GCRC indicates a deflection angle, left C-3 C-2, C-1, 0°03'; 1999 remonumentation deflection angle, left C-3, C-2, C-1, 0°03'08". (Cont'd on back)

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner (Continued):

In 1995, John Rauser performed a certified survey indicating a 3/4" square bar as the corner, with five accessories recorded. All five being found in 1999 and measuring from 0.01 to 0.5 of record.

Today in the 1999 remonumentation program I am finding a 3/4" bar in the centerline of Markley Road with tree line running to the east. Five accessories from the 1995 survey were noted on the recorded Act 132 form L. 3422, P. 498. All five were found in the 1999 remonumentation program. The measurements of the accessories compared within 0.01 to 0.5 feet from the record measurement of the 1995 Act 132 document. One accessory from a previous undated Rowe witness card (no date) compared within 0.10 of the record measurement. I accept the 3/4" bar in centerline of Markley Road as the position of corner C-2, T5N-R5E, Argentine Township.
