Description of original monument and accessories and/or subsequent restoration:

1815 GLO - Alex Holmes, Set post and 2 accessories

Found 1 3/4" Rod intersection of Fenton Road and Maple Road.

GCRC Dwg #731 - No description of monument given, shown as being at the intersection of Fenton and Maple Roads. 1911

1920-1930 GCRC Witnesses - Found stone, West 5.8' CL Fenton (5.6')(M)

1940 Plat of "Burton Woods" - Iron in pavement, 5.70' East of centerline, A-13, B-13 2819.93' (R), 2819.98' (M), A-13, A-12, 2635.86' (R), 2635.74 (M).

1991 GCRC Dwg. #2638, Field book #2120A - No description of monument given, shown on centerline of Maple Avenue, 5.6' of centerline of Fenton Road. A-13, B-1 (T6N-R7E) 2470.43', A-13, B-13 2786.90' (R); B-1 (T6N-R7E), A-13 2503.43' (R), B-1, B-13 316.47'(R), B-13, B-1 316.50'(M), A-13, B-1 2503.45'(M).

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

In 1815 Alex Homes, D.S. indicates setting a post for corner A-13 with 2 accessories set for the corner. A measurement from corner B-13 to A-13 of 42.00 chains (2,772 feet) (1998-2819.95), from corner to M-13 to A-13 482.0 chains (31,812.0 feet) (1998-21,809.98). In 1911 Genesee County road plans show the corner A-13 at the intersection of Fenton and Maple Roads with no description of the object for corner A-13. From 1920-1930 Genesee County Road Commission witnesses a stone is called for 5.8 feet east of the centerline of Fenton Road. Four accessories are shown, all of which are gone in 1998. In 1940 the plat of Burton Woods indicates an iron in pavement 5.70 east of centerline and a distance from B-13 to A-13 of 2819.93 feet and a distance from A-13 to A-12 of 2635.86 feet (1998-2635.74 feet). In 1991 Genesee County Road Commission dwg 2638 fieldbook 2120A indicate A-13 5.6 east of centerline of Fenton Road, four accessories are shown. Measurements between corner B-13 to A-13 of 2819.9 feet (1998-2819.95) and B-1, T6N-R7E to A-13 of 2503.43 feet (1998-2503.45). Today in the 1998 Remonumentation Program I am finding a 1 3/4" rod in the intersection of Maple and Fenton Roads. 1 am measuring between corner B-13 to A-13 2819.95 and between corners M-13 to A-13 31,809.98 feet, within 2.02 feet of the 1815

GLO measurement. I am also measuring within 0.02 feet of the 1940 Burton Woods platted distance between corners B-13, A-13. I am measuring within 0.12 feet of the platted distance between corners A-13, A-12. In 1998 I am finding four of the accessories from the 1991 GCRC survey which I check from 0.04 to 0.09 feet against the record measurement. I accept the position of the 1 3/4" rod in monument box 5.6' east of the centerline of Fenton Road as the best available evidence of the original corner.
