Description of corner evidence found and/or method applied in restoring or reestablishing corner:

1998 Remon

Find 1/2" O.D. pipe in monument box in centerline of Bristol Road. In 1821, J. Wampler, D.S. set a post and two accessories for corner F-11, midway and on line between corner E-11 and G-11. A distance from E-11 to F-11 of 39.93 chains (2635.38 feet) (1998, 2648.89 feet) and a distance from F-11 to G-11 of 39.93 chains (2635.38 feet) (1998, 2626.29 feet). In 1930 Genesee County Road Commission plans dwg #1006, no description of the monument is given. A distance of 1358.25 feet is given to the West rail of the P.M. Beltline RR (1998, 1359.18 feet). A distance between E-11 to F-11 of 2648.25 feet (1998, 2648.89 feet). In 1946 the Plat of Follo Acres was recorded by C. F. Alkman PS # 5432. No description of the monument is given but the plat shows it on the centerline of Bristol Road. A measurement from F-11 to G-11 of 2628.21 feet, (1998 2626.29). 1972 Genesee County Road Commission road plans dwg #2026 call for a iron in monument box for corner F-11. Four accessories are shown, three of which exit in 1998 and check very close to record. A distance between corners E-11 to F-11 2648.91 feet (1998, 2648.89 feet); F-11 to G-11 2626.19 feet (1998, 2626.29 feet).

In the 1998 remonumentation program, I am finding a ½" O.D. pipe in monument box in the centerline of Bristol Road. I am finding four accessories, one of which dates back to the 1930 Genesee County Road Commission plans, West 1358.25 feet to W. rail of P.M. Beltline RR which checks within 0.93 feet of 1998 measurement. Also the distance between F-11 to E-11 2648.89 feet which checks within 0.64 feet of the 1930 survey and 0.02 feet of the 1972 survey, indicates that the corner has remained the same since 1930. I accept the found 1/2" O.D. pipe in monument box as the best available evidence of the original corner.
