> Fnd 1" O.D. pipe in monument box in centerline of turn lane, N edge of woods line to West. In 1821 J. Wampler, D.S. Indicates setting a post with 2 accessories for corner G-12 40 chains (2640') north of corner G-13. In 1998 neither of the accessories exist and we measure post with 2 accessories for corner G-12 40 chains (2540') north of corner G-13. In 1998 neither of the accessories exist and We measure 26.46.31' (40.09ch) from G-13 to G-12. In the 1920's-30's Genesee County Road Commission notes indicate a 1" pipe with 4 accessories for corner G-12. None of the accessories exist in 1998. In 1921 Genesee County Road plan Dwg #1014 field book #1014 indicate 4 accessories, none of which exist today. No description of the corner is given. 1940's Genesee County road Plans indicate a monument box on the centerline of Center Road with a measurement from G-13 to G-12 of 2645.01 feet (1998 2646.31 feet). Also a 12" culvert 278 feet south of corner G-12 (1998 280 feet). A 1985 certified survey by Vance Kupisch L.2250, P.274 indicates a 1/2" pipe in monument box with 2 accessories, 1 of which exists in 1998 S45E, 69.88' to a PK & disc in NE face P.P. (1998, 69.90feet). 1988 Genesee County Road Plans Dwg. #2476 field book #2060 indicate a 1" pipe in monument box with 3 accessories. None of the accessories exist in 1998, although a P.P. at 69.5 feet exists in the southeast quadrant that appears to have replaced the T.P. with R.R.S. at 69,72 feet. A measurement from G-12 to G-11 2651.12 feet (1998, 2651.06 feet). In a 1991 certified survey by Vance Kupisch indicates a pipe in monument box with 4 accessories all of which exist in 1998 and measure within 0.02 feet of record.

> In the 1998 remonumentation program I am finding a 1" pipe in monument box in the centerline of turn lane (5 lanes for roadway) at the north edge of a wood line to west. This 1" pipe has been called out back to the 1920's. The measurement between G-13 to G-12 of 2646,31 checks close to the 1940's measurement of 2645.01 also the distance to the 12" culvert compares reasonably well. I accept the found 1" pipe in monument box as the best available evidence of the original corner.
