В. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

1998 Remon - Found Pinched 1" Iron Pipe In 1815 Alex Holmes set corner I-13; he set two accessories neither of which exist today. He gives no description of the object placed at this corners. 1815 measures 2648.59 feet, between corners J-13, H-13 measures 2635.60 feet. In 1927, GCRC measured 2636.40 feet between corners I-13, H-13. The 1815 GLO measure between corners I-13, I-12 measured 40 chains, In 1935 GCRC measured 2621.90 feet between I-13, I-12. I measure 2623.30 feet between I-13, I-12. Other than 1927 GCRC records indicating a stake as the object in place for corner I-13, no description of the object for corner I-13 is given than 1927 GCRC records indicating a stake as the object in place for corner I=13, no description of the object for corner I=13 is given from 1815 until 1977 when it is described as a PK nail & iron by G. Misjak, P.S. #21271 shown at intersection of Maple and Genesee Road north. He also indicates three accessories, two of which exist today; S60°E 91.21' (R), 90.85' (M) to a PK nail in P/P and West 111.7' (R), 111.72' (M) to corner I=1 T6N=R7E. In 1990 Fred Shaltz Jr., P.S. #13595 indicates finding a 1" pipe in a monument box and sets three accessories of which I am finding all three in 1998, and checking record measurement within 0.04 feet on all of them. In 1995 the object for I=13 is described as a pinch pipe by Richard Frank, P.S. #14093 with three accessories none of which exist today. I am finding a 1" Iron pipe in monument box with five accessories. Three Delta accessories from the 1990 survey which checked within 0.04 feet; a measurement to corner I-1 T6N-R7E from the 1977 George Misjak Survey which checks within 0.02 feet. Also a measurement from the 1927 GCRC survey between corners I-13 and H-13 of 2636.40 feet as compared to the 1998 measurement of 2636.60 feet, within 0.80 feet. Based upon the type of survey equipment utilized in 1927 until present, I feel that the 1" pipe in monument box found in 1998 is the same corner position as the stake in 1927, the PK nail & iron in 1977 the 1" bar in 1990, and the pinch pipe in 1995. I accept the pinched 1" iron pipe as the best available evidence of the original corner.

I set the standard Bernsten monument 55-A-5-BR-30 (3 1/4" D. brass cap stamped "Genesee County Remonumentation Corner 32332, 1998) with 30" x 2 3/8" O.D. stainless steel tube with plastic base.
