B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:
1995 Fnd 1/2" rod in mon. box and 1 accessory from 1978 (pk & washer in P/P to NW at 120.74'), also fnd occupied mature tree row to the North of corner
The occupied mature tree row to the North (suggesting the old fence line, as shown in 1934 GCRC Notes), as well as the witness of a pk hail (with washer) in a 1/4" bickory or butternut (same family of trees) tree is present on both the 1972 and 1978 Rowe Engineering surveys which demonstrates that the "T" iron (called for in the 1960 i GCRC witnesses) found in 1972 and the 1/2" re-rod in a monument box found in 1978 are in the same relative position. The pk hail (with washer) in a power pole to the NW at 120.74' is the only surviving accessory from the 1978 Rowe Engineering survey. I feel that the measurement today verses the measurement observed in 1978 are within a reasonable tolerance and demonstrates that the found 1/2" rod in a mon box today is most likely the same 1/2" re-rod in a mon box that was found in 1978, which is in the same position as the "T" iron found in 1972, which was called for in the 1960's by the GCRC. The witnesses from the above mentioned surveys up until the 1972 Rowe Engineering survey call for anchor posts to the North and South of the corner which goes along with the 1934 GCRC survey in which they show fine to the North and South along the evident 1/4 line. It is therefore that I conclude that all of the above mentioned monuments are in the same location as the evident 1/4 line present in 1934. Upon review of this evidence, I conclude that the found 1/2" rod in a mon box is a faithful and careful re-establishment of the position of the original corner.


