

Description of original monument and accessories and/or subsequent restoration:

G.L.O. Not a GLO corner.

1920, ROD - Plat of Elm Crest, DL9, P11, Plus Pastorino, RLS #603; not show corner but gives distance C/L Alfred Rd (B-7) to "SW Cor Sec 18"[A-7 but actually Cor M-7] and distance north to N line plat of 2644.59' (by calcs) but not identify N line as any specific line; part of SW 1/4 Sec 18.

1921, ROD - Plat of Buick Subdivision, PL10, P31, Pius Pastorino, RLS #603; shows corner but not Identify; gives distance from "SW Cor Sec 18 [A-7 but actually Cor M-7] to S. line of 2674.62' but not identify S line as any specific line.

Description of corner evidence found and/or method applied in restoring or reestablishing corner:

Did not find position for corner preserved by any monumentation. Re-established corner position by the proper procedure of the mean or midpoint of the distance from Cor A-5 to A-7 = 5318.99' / 2 = 2659.49' on line between the Standard Cors M-6 and M-7.

I conclude that the 1/4 Cor. A-6 is lost and it is to be re-established by the proper procedure of the mean or midpoint of the distance from Cor. A-5 to A-7 which places it south of Cor. M-6. I set it on the Township line between Standard Corners M-6 and M-7. I note the Pastorino in the Buick Subdivision probably measured from Standard Corner M-7 to M-5. His distance of 2674.62' doubled would give a distance of 5349.04' for the "mile" measurement, compared to my EDM distance of 5338.13'. Half of my measurement would be 2669.06'; 1/4 of my measurement would be 1334.53'. I measured 2669.19' from Cor. M-7 to M-6 which is similar to Pastorino's distance. The west line of the plat of Buick Sub is 1337.21', while 1/4 of his distance is 1337.31.' Thus it appears he subdivided the distance but did not have the correct corners, the Closing Corners A-5 and A-7 (Cont'd on back)

We traversed around Sec. 18 in a retracement survey as part of our Remonumentation procedures. We also reviewed the County aerial photos for 1996 and 1992. There is no evidence to indicate any occupation or land use along the E-W 1/4 line. With the GM Delphi plant and the landfill/gravel pit in the E ½ and the two plats in the W ½ (which did not have the 1/4 line) there does not appear to be any title lines dependent on this corner.

I set the corner as noted as a careful and faithful re-establishment of the position of the original corner. It does not appear this corner controls surveys of any parcels in the section.
