

M-10 Standard 1/4 corner common to Sec. 25, T17N, R1E found 1/2" rebar with reaction below per L.C.R.C. P. 113 monument accepted as the best available evidence of the position of the original corner. Accepted by Gladwin County Peer Review Group on 12-10-93,

M-9 Replace 3/4" iron rod with 2" Gladwin County aluminum cap on 5/8" x 36" rebar in mon. box - 1± W of centerline of M-30. S 55° W 110.22' to nail and tag in N side P.P. N 20° E 129.21' to nail and tag in W side Light Pole. N 40° E 160.20' to NW corner (wood face) of Building. N 50° W 188.30' to nail and tag in S side 18" Apple. N 75° E 108.90' (N 78° E 109.41' to SW corner block building -M.D.O.T.) to SW corner (wood face) of Building. N 155.44' (155.49 - M.D.O.T., 155.76' GLO) and W 0.32' to closing corner E-11 - T17N - R1E.

M-10 Replace 1/2" rebar with 2" Gladwin County aluminum cap on 5/8" x 36" rebar- down 6". N 20° W 43.80' to nail and tag in SW side 4" Ash.

S 10° E 95.93' to nail and tag in E side U.P.

N 80° E 12.19' to nail and tag in N side 3" Ash.

N 30° E 96.34' to concrete mon.

N 25" W 43.42' to nall and tag SW side 6" Ash.
