Cap on 1" x 36" galv. iron pipe by proportion to Courtright Survey between 'C3' and reestablished E 1/16 cor. common to Sec. 5 & 8 per Rec. Survey L. 1, p. 392 and on line between 'C3' and 'E3'. Grid distance to 'C3' is 2605.12' (2605.03' – AVC) and distance to E 1/16 is 1302.56' (1302.51' – AVC) and distance to 'E3' is 2602.23' (2605.03' - AVC). Centerline of E-W gravel rd. is 30.5' North. Found nail 20.78' (20.62' - R) West for apparent SW Cor. Parcel 21 per Courtright Record Survey (No iron noted on Survey). Courtright notes show 'D3' is midway between Sec. corners. Set Mon. is 1.44' East of split. N75°08'W 2.93' of set DNR Mon. found ½" CIR #27458. This ½" CIR didn't fit Courtright survey or SP position so couldn't accept as 'D3'. DNR Mon. accepted as the best available evidence of the position of the original corner.
