 - J. E. Richardson 1968 a 3/8" bar was fd. in old road, but it could not be verified by original wit's or by comparison with topo notes. Therefore, it was not accepted. Set 5/8" x 36" bar on line and mid point between Sec. Cors Tw. Maple 6" S53°E 15.92'; Maple 4" S38°W 18.30';

Fd. 3/8" bar and 2 Wit's is N62°51'E 63.23'; Tw. Maple 7" N53°E 9.63'

- D7 1/4 Corner common to Sec. 17 & 20 Fd. 5/8" x 35" rebar at N. End of single strand fence to South. Centerline of N-S'ly 2-track is 26' E. Fits Richardson's SW BT and the stp. of the NE. Searched for 3/8" bar noted by Richardson but it falls in Buldozed 2-track and is gone. Could find no evidence of witnesses or capped iron noted by Grondin survey. No GLO evidence found. Measured East 561' ± vs. 627' - GLO and 564' - JER to W. Bank of stream - 8-10' wide. 5/8" rebar accepted as a careful and faithful reestablishment of the position of the original corner.
