A. Description of original monument and accessories and/or subsequent restoration:

Original corner established by John Burt on 8/31/1847. Original bearing trees:

Hemlock	16"	N.11° E.	29 links (19.14')
Cedar	6"	N.77° W.	48 links (31.68')
Cedar	10"	S.20° W.	24 links (15.84')
Hemlock	14"	S.81° E.	18 links (11.88')

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

Corner position restored at record bearing and distance from the remains of the following original B.T.s:

Stump hole with fragments of Hemlock bark at N.11° E. 19.1'  
 Series of root holes with fragments of Cedar wood at N.77° W. 31.7'  
 Windthrown stump hole with portions of Cedar wood downwind at S.20° W. 15.8'  
 18-24" decayed Hemlock stump with portions of B.T. blaze overgrowth at S.81° E. 11.9'

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

At the corner position I set a 3/4" X 3' long aluminum rod with a 3 1/4" stamped aluminum cap and the following new B.T.s:
