Corner established by Austin Burt on August 27,1847. Original B.T.s--Sugar 8" N.35 E. 29 links (19.14') --- Y. Birch 10" N.40 W. 31 links (20.46') --- Corner restored by Donald D. Lappala, RLS 12585 on 6/8/71 from the remains of the original bearing trees. He set a 2" iron pipe with a 3" stamped brass cap and the following new bearing trees --- 10" (8") Sugar Maple N.05 E. (N.05 E.) 12.0' (12.05') --- 9" (9") Sugar Maple S.54 E. (S.51 E.) 11.2' (11.18') --- 7" (7") Y. Birch S.40 W. (S.39 W.) 8.9' (8.97') --- 4" X 4" Cedar sign post s.78 E. (S.79 E.) 2.6' (2.6')

Corner recorded in Gogebic County in USFS Liber, Page Z-19 on 8/10/72.

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner: Act 74 research form on file with Gogebic County records.

Recovered the monument as described and the bearing objects as noted in parentheses above.

A depression remains from the original Sugar bearing tree.
