A. Description of original monument and accessories and/or subsequent restoration:

Corner established by John Burt in August, 1847. Original B.T.s --- Cedar 6" N.68 E. 31 links (20.46') --- Cedar 22" N.59 W. 33 links (21.78') ---

Bill Stuth, Wisc. RLS recovered the original post and the remains of the two original B.T.s in 1984. John Goss (23509) on 10/8/86 recovered the remains of the two GLO B.T.s and monumented the corner with a 12 X 36 iron pipe with a 2" stamped brass cap and established the following new bearing trees. --- 13" Black Ash N70 W. 9.5' (10.48') --- 15" (16") Black Ash North 3.6' (4.74') --- 9" Black Ash S.70 W. (S.63 W.) 33.1 (33.39') ---

Description of corner evidence found and/or method applied in restoring or reestablishing corner: Distances to 1986 B.T.s were measured to the B.T. face blaze. Distances now measured to 10p nail in middle of the side of the tree.

Corner position found marked by the monument as described and the 1986 B.T.s Due to recent logging activity, no evidence as noted in parentheses above. remains of the original B.T.s.
