He set a  $2\frac{1}{4}$ " X 5' iron pipe with a 3" stamped brass cap and the following new bearing trees: --- 9" Elm ( dead and down) N.53 W. (N.53 W.) 28.5' --- 7" (8") Sugar Maple N.47 E. (N.48 E.) 21.1' (20.74') --- 6" (7") Sugar Maple S.39 E. (S.37 E.) 23.7' (23.66').
