A. Description of original monument and accessories and/or subsequent restoration:

Corner established by Austin Burt on August 11, 1847. Original B.T.s --- Sugar 24" N.45 E. 24 links (15.84') --- Sugar 14" N.46 W. 30 links (19.80') --- Corner restored by Donald D. Lappala, RLS 12585 on 9/14/72 from the remains of the two original bearing trees and from natural feature ties and line trees east and west. He set a 2" dia.iron pipe with a 3" stamped brass cap and the following new bearing objects: --- 11" Elm (dead and down) N.88 W. 11.3' --- 7" Elm (dead and down) N.63 E. 15.6' --- 5" Elm (dead and down) S.10 E. 24.0'--- Corner recorded in Gogebic County in USFS Liber, Page Z-15 (T.48 N.).

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

Act 74 research form on file with Gogebic County records.

Recovered the monument as described and the bearing trees as noted in parentheses above.

Stump holes are all that remain of the original bearing tree.
