Corner established by Austin Burt on Aug. 13, 1847. Original B.T.s --- Tamarack 10" S.71 W. 21 links (13.86') --- Tamarack 12" N.53 E. 49 links (32.34') ---

Corner restored by Donald D. Lappala, RLS 12585 on 8/9/68 at the point of the original Spruce post, the remains of the two original B.T.s (one still scribed) and from an original, scribed W.T. stub. He set a 2" dia. iron pipe with a 3" stamped brass cap and the following new B.T.s: --- 5* (7") Cedar (now dead) N.57 E. (N.58 E.) 24.7' (24.64') --- 8" (10") Cedar S.53 E. (S.52 E.) 8.5' (8.37') --- 4" Cedar (5" dead Cedar stub) S.75 W. (S.76 W.) (13.28')

Description of corner evidence found and/or method applied in restoring or reestablishing corner:

Corner recorded in Gogebic County in USFS Liber, Page N-25 on 3/31/69.
