"Found post with iron bolt in top, somewhat doubtful, witnessed by an Elm 16" N29°W 52', not marked", Survey by County Surveyor Allyn recorded in L.2, Pgs.214-215 of G.T. Co. Surveyor Records. "Found good corner, a large post set deep in the ground coming to the top of the ground with iron in center of post", Survey by C.P. Tuller date 1902 and recorded in G.T. Co. Surveyor Records. "Cedar post with iron bolt in center found", LCR by J.L. Wilcox recorded in L.2, Pg.361 of G.T. Co. Land Corner Records. "Found 1/2" iron bar as recorded in L.2, Pg.361 of G.T. Co. Land Corner Records", LCR by Robert F. Mitchell recorded in L.3, Pg.215 of County Land Corner Records.

Description of corner evidence found and/or method applied in restoring or reestablishing corner:

I-7) SE Corner of Sec. 15, T25N-R10W; "Found a 4" round by 1' long Cedar post with a iron bar and a bolt driven in it's center and cobblestones surrounding it, found no remains of post below 1 1/2' of the surface, as recorded in L.3, Pg.215 of the LCR's of G.T. County and is accepted as a careful and faithful perpetuation of the position of the original corner. Remonumented this position with a 2 1/2" x 30" flanged bottom galvanized iron pipe with 3 1/4" brass cap stamped GRAND TRAVERSE COUNTY REMONUMENTATION, 7" below the surface of the gravel road.


