"Found a ½" square boat spike driven in the old ¾" iron pipe 1' below surface with several rocks packed around it" as recorded by Allyn in Liber 2, page 88 of the County Surveyors records and is accepted as a careful and faithful reestablishment of the position of the original corner. Added a 2 ½ x 30" flanged bottom galvanized iron pipe with a 3 ½ inch brass cap stamped GRAND TRAVERSE COUNTY REMONUMENTATION to the position of the found pipe 6" below the surface of the NS blackfop road in a monument box.
