

- B. Description of corner evidence found and/or method applies in restoring or re-establishing corner:
- B5- ¼ corner between sections 7 & 18- Fnd. 1" Axle Shaft with leaning and disturbed DNR 4" Aluminum Cap on 1" Pipe on South side. DNR Mon. had been run over but axle was on North side and straight. Axle fits Waterman's survey. The axle per Waterman was accepted as a careful & faithful perpetuation of the position of the original corner.
- C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:
- B5- Replaced 1" X 2.6' long axel shaft and DNR Mon. along side with 3 1/4" 'Grand Traverse County Remonumentation'

Brass Cap on a 2 1/2" X 30" Galvanized Iron Pipe in ring of stone. Set Orange Carsonite Post 1' N and Reset Cedar Post 1' E.

S35°W 22.75' to set nail and tag in NW side of 16" Twin Red Maple (CFR)

N50°W 11.31' to set nail and tag in NE side of 8" Red Pine (CFR wit. Blazed and Scribed)

S71°E 8.30' to set nail and tag in S side of 8" Red Pine (CFR wit. Blazed and Scribed)

N66°E 18.63' to set nail and tag in SE side 9" Red Pine scribed 'XBT'
