Found old meandering Barb wire on ground to north - 30' +/- east of S.P position. Dug in 2 track in line with fence but found nothing. Could find no conclusive GLO evidence, corner lost. Set 3 ¼ " galvanized iron pipe by single proportion between l5 & K5. Position is in centerline of old E-W trail Rd. Measured west 376' +/- 5' (388'- GLO) to meandering stream crossing. Overall GLO mile distance is only 3.5' +/- short. 3 1/4 " brass cap mon. accepted as a careful & faithful reestablishment of the position of the original corner. Reference pt. - found 3/4 " I.D iron pipe - N64°26'W 8.52' from J-5 . Talked to Ormond Danford - 84 years old - owner of local tree farm since 1940's. Says he or P.
