(I11) Corner common to Sections 26-27-34-35. 1848 - Established by S.W.Higgins, Deputy Surveyor. Set post. Birch 30 S40W 6 links, Maple 24 N20W 32 links. 1962 - Remonumented by Billy D. Buckler RLS 'from badly decayed birch stump which may have been original B.T. (30" Birch S40W, 06 links). Distances to corner N and S check good". Set 1" iron pipe with 4" brass cap. 5" H.Maple S82W 47 links, 5" S.Maple N63W 21 links, 7" Aspen S40E 05 links.

(13-Sec. 34) Southeast 1/16 corner, Section 34. Not established in the original survey.

- B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:
- (I11) Found the 1962 monument in good condition and at record bearing and distance from the 1962 NBT Maple NW, now 8" DBH, in good condition. The other two 1962 NBTs were not apparent above the snow. Accepted the monument as the best available evidence of the position of the original corner.
