A. Description of original monument and accessories and/or subsequent restoration:

M-7; Section Corner common to Sections 13 and 24, T52N, R34W;

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

M-7; Section Corner common to Sections 13 and 24, T52N, R34W;

Found a 1 1/2" (I.D.) x 35" iron pipe 5 inches below the surface as recovered by Keith Sackett, PS in 1977. Replaced this monument with a 1" (I.D.) x 36" galvanized iron pipe with cap stamped as to location. This corner falls on the physical centerline of a north-south, 10-foot wide, woods road. Accepted as the best available evidence of the position of the original corner.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

M-7; Section Corner common to Sections 13 and 24, T52N, R34W;

Set a 1" (I.D.) x 36" galvanized iron pipe with cap stamped as to location 8" below the surface.

- i) Set 7" spike NW/side 6" Sugar Maple N47°E 61.32'
- ii) Set 7" spike N/side 24" Twin Red Maple N80°E 16.73'
- iii) Set 7" spike N/side 8" Sugar S63°E 33.63'
- iv) Set 7" spike N/side 9" Sugar Maple S60°W 18.78'
- v) Set 7" spike N/side 12" Sugar Maple N72°W 19.81'
- 6" Steel fence post w/ yellow sign West 20.3'

(i) and (iii) are marked with upper and lower blazes. The lower blaze is scribed "NBT". Both blazes and a band around the tree at the upper blaze were painted red.

(ii), (iv), and (v) are Mr. Sackett's new bearing trees and are further described in Part A. These new bearing trees were also painted red.

*This corner is also A-7 of T52N, R33W.

A. Description of original monument and accessories and/or subsequent restoration:

M-7; Section Corner Common to Sections 13 and 24, T52N, R34W;

Originally established during U.S. Survey conducted by William Burt, D.S. in 1845 and monumented with a wood post witnessed by a

Sugar 12 N43°E 43 lks.

and a

Sugar 13 N21°W 42 lks.

During the subdivision of T52N, R33W, by William Burt, D.S. in 1849, this corner was further witnessed by a

Yellow Birch 15 S22°E 26 lks.

and a

Sugar 12 N42½°E 42 lks.

On 18 April 1977, Keith Sackett, P.S. #19006 recovered and accepted a "1½ (in.) I.D. x unknown length iron pipe buried in old logging road". According to a Land Corner Recordation Certificate prepared by Mr. Sackett dated 3 August 1977 and recorded on 20 December 1977 in Volume 1 on page 483 of the Houghton County Land Corner Records, this monument was left in place and the following accessories were established:

9" Sugar Maple S58°W 18.4'
Presently alive and 10" in diameter having partially healed upper and lower blazes with scribing visible.
Set 7" spike N/side Measured S60°W 18.78'

12" Sugar Maple N69°W 19.2'
Presently alive and 15" in diameter having partially healed upper and lower blazes with scribing visible.
Set 7" spike N/side Measured N72°W 19.81'

16" Maple N80°E 16.2'
Found an alive twin red maple 14" in diameter having partially healed upper and lower blazes with scribing visible.
Set 7" spike N/side Measured N80°E 16.73'
