- A. Description of original monument and accessories and/or subsequent restoration:
- (L9) Quarter corner common to Sections 24 and 25. 1846 Established by S.W.Higgins Deputy Surveyor. Set post midway and on the Section line between Section corners 39.92 chains east and west. Hemlock 12" NO5W 26 links, Sugar 12" S05E 30 links. 1966 Reestablished by Billy D. Buckler RLS midway and on line between Section corners. Corner recorded in 1976 by K.L.Sackett RLS. Set 1" pipe with 4" alum. 8" Y.Birch S37W 19.2', 7" Y.Birch N35W 14.0'
- (M9) Corner common to Sections 24-25 T53N-R35W and Sections 19-30 T53N-R34W. 1845 Established by W.A.Burt Deputy Surveyor. Set post. Hemlock 14" S40E 47 links, Fir 8" N30W 26 links. 1846 Additional B.T. by S.W.Higgins Deputy Surveyor: B.Ash 12" N60E 40 links. 1957 Remonumented by Billy D. Buckler RLS "from one black ash B.T. bearing N60E 40 links. Found overgrowth and scribe marks very plain. Tree down". Set 1" pipe with 4" brass cap. 10" Y. Birch N35W 26.5 links, 12" Y.Birch S58E 46 links, 10" Y.Birch N57E 53 links.
- B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:
- (L9) Found the monument described in the 1976 record, in good condition, and at record bearing and distance from the 1976 witnesses. Found no record of subsequent work dependent upon the position of the 1976 monument. My measurements show that the 1976 monument was installed S65W 14.5' from the midway position intended and I did not accept the monument of record as marking the position of the corner. Reestablished the position for the corner midway and on the Section line between Section corners 2558.89' east and west. Removed the 1976 monument.
- (M9) Found the 1957 monument in good condition and at record bearing and distance from the 1957 witnesses. The Y.Birch NW is in good condition with overgrown blazes, the Y.Birch SE is cut stump with old blaze visible, the Y.Birch NE is dead and down. Accepted the monument as a careful and faithful perpetuation of the position of the original corner.
- C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

(L9) Set 1"IDx32" I.pipe with 4" alum. MDNR cap.
Set measuring nail with MDNR tag in the side of:

Set measuring nail with MDNR tag in the side of: 13" Y.Birch N27W 17.8' old blazes 1957 NBT 4" Sugar N53E 6.0' mrkd "S19 NBT" 11" Hemlock S45E 23.0' "S30 NBT" 9" Y.Birch S61W 29.3' "S25 NBT" Sq'd cedar post adjacent. Bearings are magnetic.
