A. Description of original monument and accessories and/or subsequent restoration:

Survey #1162, July 14, 1894, Geo. Mark, Co. Surveyor: Stone & brick; W. Oak stump S. 57 1/20 E., 116 links.

C.D. Plye, R.L.S. #3165 found pointed stone surrounded by broken brick and china 2' below surface. Reset 1" iron pipe over stone 4" below surface. A. Kurzy, Dec. 1970 found iron rod, according to LCRC Liber 1, Page 57, Nov. 12, 1971, by A.J. Hatt.

A. J. Hatt, LCRC Liber 1, Page 57, Nov. 12, 1971: set P.K. in pavement.

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

Found 1"x5" iron pipe over stone. Top of iron pipe was 4" below pavement surface. Top of stone was 1.2' below pavement. Good deposit of brick & china was found around stone. Removed stone and replaced with 3/4"x36" County remonumentation bar in monument box and is accepted as a careful and faithful perpetuation of the position of the original corner.
